DUTIES: Performs beverage service functions in a bar or lounge area. Asks patrons what beverages are desired and writes the order on a guest check. Describes or suggests cocktails, highballs, wines, or other beverages upon request. Gives order to bartender. Receives and places beverages on a small tray and serves patrons. Collects payment from patrons and settles account with bartender or cashier. Observes when patron leaves and cleans tables. Maintains clean work area. Performs other related duties as assigned.

QUALIFICATION REQUIREMENTS: Skill to serve beverages in the proper manner. Knowledge of composition of popular cocktails and types of beverages served. Availability of wines and their proper serving temperatures. Knowledge of simple math calculations in order to tabulate checks. Ability to recognize intoxicated patrons when serving alcohol. Ability to lift/carry objects weighing up to 20 pounds.
